



# Tour Reservation Contract - ENYSSA ODP

**Italy: July 26<sup>th</sup> - August 3<sup>rd</sup>, 2017**

**Estimated Tour Cost 35 Passengers = \$2,739 per person<sup>1</sup>**

**Estimated Tour Cost 30 Passengers = \$2,859 per person**

**Estimated Tour Cost 25 Passengers = \$2,997 per person**

This quotation is based on current land service and air travel prices. It is calculated based on the rate of international currency exchange on 02/03/17 of €1 = \$1.08. It is based upon above stated number of paying passengers traveling. The quote price includes a \$93 allowance for airline fuel surcharges and airline taxes. This estimated quotation will expire on **February 24<sup>th</sup> 2017**<sup>2</sup>.

## (A) Payment Schedule

Payments will be distributed among 4 installments. The installment dates are structured to allow timely payment of airline / land vendor invoices. Late payments jeopardize the tour quotation.

Quest Sports Travel will calculate and publish the Final Balance Invoice on **May 31<sup>st</sup>, 2017**.

Check payments should be made payable to **Quest Sports Travel** and mailed to the address above. Select "Mail In Check" on the checkout page for this option.

If paying by Credit Card you will have the option to pay in full, or to pay the installment plan stated above. If selecting the installment plan the deposit will be charged at the time of registration and future installments automatically charged on dates listed above.

## (B) Terms of Cancellation

Quest Sports Travel must fulfill responsibilities with vendors (e.g. airlines, hotels) in advance of the tour and is therefore able to refund cancellations as follows (per person):

<b>\$250.00 penalty plus the cost of protection plan, if purchased</b>	Cancel after <b>03/02/17</b> but before <b>03/27/17</b>
<b>\$500.00 penalty plus the cost of protection plan, if purchased</b>	Cancel after <b>03/26/17</b> but before <b>05/02/17</b>
<b>\$750.00 penalty plus the cost of protection plan, if purchased</b>	Cancel after <b>05/01/17</b> but before <b>05/31/17</b>
<b>No refund<sup>3</sup></b>	Cancel after <b>05/30/17</b>

All cancellations must be in writing and submitted to Quest Sports Travel before the stated dates in order to receive the appropriate refund. Refund payments are made as quickly as vendor reimbursements allow.

<sup>1</sup> The quoted tour cost is a cash discount. Credit card payments are accepted but will be charged at the tour cost before the cash discount (+3.5%). Credit card processing fees can not be refunded if registration is cancelled

<sup>2</sup> Final Tour Price will be affected by (a) group size; (b) rate of international currency exchange at time of balance invoice; (c) changes in airline departure tax and fuel surcharge.

<sup>3</sup> If group or individual passenger opts to ticket prior in advance of no refund date the airfare cost is non-refundable. Penalty rates listed above are replaced by cost of airline ticket + \$200 admin fee



### (C) Travel Protection with Travelex Insurance

QST recommends you purchase a travel protection plan to protect you and your trip investment! Consider travel protection for Trip Cancellation/Trip Interruption, Emergency Medical and Emergency Evacuation/Repatriation, Trip Delay, Baggage Delay and more!

**360° Student Group Premier Plan**= Youth Group plan requires a minimum of 10 group members and a ratio of 80% youths (under 25) to 20% adults. The Travel Protection cost for this plan is \$100 per person. Only players traveling alone should select this option.

**Travel Select Protection** = Individual policies. Plan terms allow 1 child (under 21) per adult without additional charge. The Travel Protection cost for this plan is \$166 (average of \$83 per person if purchasing for 1 parent and 1 child; assumes parent age between 35-59 years old. Pricing is higher for an older adult. Please contact us for exact pricing if required)

### (D) Airline Information

Airlines reserve the right to increase departure tax (based on airport fees / government security taxes) and fuel surcharges at any time. To maintain the quoted tour price it is essential that payment installments are received on the stated dates.

To minimize any increases Quest Sports Travel strongly recommends that the group 'ticket' all passengers as early as possible. 'Ticketing' requires payment in full to the airline. Once ticketed airfare costs are non-refundable as per footnote 3 of Section (B).

The departure city for this tour will be **New York JFK**. All efforts are made to secure the most direct and cost effective routing. Routing and cost implications will be discussed with tour leaders before publication of flight details. Flight details will be available by **February 3<sup>rd</sup>, 2017**.

**Flight Deviations:** (i) Airline rules allow flight deviations on either the departure or the return legs of the group reservation, as long as the return is made from the same airport as the main group. Airlines charge a deviation fee to do so. The fee depends on the airline. Airlines may also limit the time pre/post tour of travel and may charge additional cost based on availability on date of travel.

**LAND ONLY PASSENGERS:** If you do not live in the **New York JFK** area and would like to make your own flight arrangements from another airport, you can travel as a 'Land Only' passenger. In doing so, your tour price will be reduced by the exact cost of airfare and taxes. At the time of the quote, this is \$849. If required, Quest Sports Travel can assist in securing airfare from your airport of choice. Likewise, if you opt to secure your own airfare using frequent flyer miles (see below) you will also travel on a 'Land Only' basis. If you are traveling "Land Only" you must inform Quest Sports Travel at least 91 days prior to departure so that your seat is released before it becomes payable in full and non-refundable.

**Frequent Flier Programs:** Airlines do not accept frequent flier miles as payment for group airfare. If a traveler wishes to use frequent flier miles they must secure their own airfare and will pay Quest Sports Travel a 'Land Only' cost. No alterations will be made to the published itinerary to service individuals traveling separately from the main group.

**Additional Passengers:** Additional passengers (parents, siblings, relatives, friends) are welcome (and encouraged) to join the tour at any time as long as seats are available on the airline's group reservation. Any passengers joining the tour after the group has utilized with the airline (confirmed # of seats no less than 90 days before travel) will be subject to airline costing on that date.



**Travel Party Roster:** An accurate final travel party roster is due by **May 30<sup>th</sup>, 2017** for airline ticketing. As per Section (C) Airline Ticketing - Quest Sports Travel strongly advises supplying the roster in advance of this airline deadline. Once tickets are issued they are non-refundable and non-transferable. Should a change be necessary after ticketing a new ticket must be issued and paid in full at the rate quoted at the time of new issue. If the final Travel Party Roster is not submitted by the aforementioned date the airline reserves the right to CANCEL the reserved seats.

**Rooming List:** Final Rooming Lists, including room upgrade requests and any specific dietary requirements are due by **May 30<sup>th</sup>, 2017**.

**Room Upgrades:** The tour price is based on **Triple Bedded Rooms**. Room upgrade surcharges will apply for twin (quoted at €40 per person) and single (quoted at €220 per person) bedded rooms. The US \$ value of these room upgrades will be calculated on the same date as the Final Tour Price.

**Passports:** Passports are required for international travel. Applications are available from the United States Post Office. Please allow at least 20 weeks for processing.

**Entry Visas:** An entry visa is required for travel to some countries, including Australia and Brazil, by US citizens. Visa information can be obtained by contacting the Embassy of the specific country to be visited. Visa charges are not included in the quoted tour price and Quest Sports Travel is not responsible for securing a traveler's entry visa.

**Final Itinerary:** Quest Sports Travel will review the Final Itinerary with the group leader approximately 3 weeks before departure. This review will occur no later than **July 5<sup>th</sup>, 2017**.

**Distribution of Information:** The approved Final Tour Package is sent to the tour leader no less than 14 days prior to departure. The Final Tour Package includes airline tickets, the final itinerary and supplementary information to be distributed to each passenger. Quest Sports Travel is not responsible for lost airline tickets after distribution to the tour leader and suggests holding all tickets until the group meets at their departure airport. Your Final Tour Package will be distributed no later than **July 12<sup>th</sup>, 2017**.

**Travel Protection:** Quest Sports Travel recommends travel protection to help protect you and your trip investment. Prior to purchase, you may request copy of the Description of Coverage which includes a summary of the plan details on benefits, coverages, limitations and exclusions.
